## **RECOVERY PROGRAM**

With the start of a new year, we go all the way back to Step 1! During the odd years, I will post about the recovery program and list some exercises that you can write and journal about. I'll be using the Gamblers Anonymous: A New Beginning red book, and our Gamblers Anonymous Writing the Steps booklet for these steps. Each of these items can be purchased at the ISO store online at [www.gamblersanonymous.org](http://www.gamblersanonymous.org).

Each month, I'll list the recovery step that coincides with that month. There will be information about the steps taken from the red book and then some exercises you can do from the Working the Steps booklet.

Do you have a favorite step that you've worked on? Your least favorite? I would love to hear from you and your letter could end up in a future edition of the bulletin!

For me, my favorite to work was Step 4. I know, I know, it sounds crazy. I loved being able to get all of that out of me and onto paper. I can't say that I have a least favorite. If I absolutely had to choose, I'd say Step 8 or Step 9. I had to put

myself on my list in Step 8 and then in Step 9 I actually had to make amends to myself. It was easy for me to do that with other people, but not so much for myself.

***STEP 8 - Made a list of all persons we had harmed and became willing to make amends to them all.***

In your fourth step inventory, you made a list of the improper actions that you did as well as the good, constructive accomplishments. In Step Six, you made a list of character defects. Now, Step Eight asks you to make yet another list. This one is to identify all those you have harmed, then, to become willing to make amends to them all.

First on the list, put yourself, you should have no doubt whatsoever with this choice. You've harmed yourself spiritually, mentally, emotionally, physically, and financially.

Have you harmed family, fellow workers, employer, church members or anyone else? What is harm anyway?

Harm seems to be abusing others and taking from them the right to lead their own lives. Family members loved us and we were unable or unwilling to return that love. Perhaps, instead, we failed to provide adequately for them. Was that stealing? Perhaps, as the addiction progressed, we stole anything we could from our family or from anyone that was available.

One thing is certain. We stole time and this can never be regained. Money problems will eventually be worked out but the time lost is gone forever. With the help of our Higher Power and the program working, one day at a time, we never again will lose time or money unless we choose to return to gambling. The choice is ours, to gamble and risk progressive deterioration or not to gamble and develop a better way of life.

Did we lie? To whom and how much did we lie?

Good judgment in making this list is vital. Do not assume harm. Look at each instance and list it if you feel you did harm to another. A good yardstick is to ask yourself whether omitting a name might later return to "bug" you. If yes, add that name. Let's say you wasted many hours at work as you waited and prepared your gambling actions. Now, in your new way of life, you can show your boss someone with a clear mind who can work properly, giving more than is expected.

If goods or monies were stolen, all should be returned in a practical manner. A second story man can hardly return his ill-gotten gains without endangering himself and his family; but he might leave money in an unmarked envelope to atone for the theft. So, these harms should be listed. The method of making restitution will be determined in the step which follows. To be forgiven, one must first forgive others and then oneself. Therefore, don't leave off the list a person you harmed but who had also harmed you. The entire aim is to set right the harm one has done – nothing else matters. This step is starting your return to society. Properly done, all fear will dissipate, and you will be free to talk and move about as a normal person.

The list should include **everyone** you have harmed. After having the willingness to make amends, you will be able to resume a beneficial role in society, usually for the first time in many years.

*Step Eight is the beginning of our public relations policy and the end of isolation from our fellows.*

1. A fascinating adventure with our newfound knowledge.
2. Back-tracking to survey human wreckage is required.

Pete K. welcomed everyone to the Board of Trustees Spring meeting and reminded us why we are here – to help the compulsive gambler who still suffers.

He went over some housekeeping rules and explained Points of Interest and Points of Order.

**G) ISO / Lifeline – KC B.**

KC reported on the state of Lifeliners. There is an average of 197.7 Lifeliners each month. There are 118 trustees with 44 of them being Lifeliners. Our total number of Lifeliners is 353. With 44 of them being trustees, that's 12.46% of all Lifeliners.

For the 12-month period, we had -9.25% less given from Lifeliners than in the previous 12 months. Our total for this current 12-month period was \$89,917.11.

**H) Report from the Board of Regents – Ara H., BOR Chair**

Ara gave his report on the Board of Regents and the International Service Office. In our operating account, we have \$117,450.39. For the fiscal year, which ends in June, we are in the positive of \$5690.76.

One of the most important things, we have welcomed the BOT chair to our monthly meeting. It's been a great experience having the chair (or co-chair) present at our meetings to give reports.

We implemented a Zoom call for the incoming candidates for the Board of Regents. Trustees were invited to attend to learn more about them. Ara expressed some different ways we could have done it to make it better and more well attended. It was a learning experience for all of us. It was the first time it happened.



The ISO website has been moved to a new website and had issues at the beginning. The company we hired did not have expertise in our type of business. We addressed the issues the best we could and found a GA member who could help us out with the website pro-bono and has been helping for several months.

Ara also went over several items of interest that the Board of Regents or the ISO have addressed. Such as Unity Step 7 decisions and pieces of literature that still have the wrong address on it.

There was a lot of open discussion and questions on the website and finances concerning the ISO.

#### **I) Trustee Meeting Report-KC B., IES**

Cherry Hill- Fall 2024

There was a total of 55 registrations for Cherry Hill, collecting \$2750 (not including pre-registrations).

There was a total of \$775 collected from Lifeliners and a total of \$751 collected during the sessions.

and getting bids at hotels for an International Conference in the Fall of 2027 to coincide with Gamblers Anonymous 70th anniversary.

### **Digital Strategy Committee**

**Mission Statement:** The purpose of this committee is to give guidance and suggestions to the Board of Trustees on the most efficient use of digital media in order to share our message with the compulsive gambler who still suffers.

**With the Trustee What'sApp Group** there are currently 94 members, 21 Past Trustees, 16 members outside of North America 57 Current Trustees.

**There are 117 Current Trustees in total, 44 current Trustees are not part of this group.**

**Item 21 on the agenda is a result of a discussion started on the App:** Since the Trustee WhatsApp Group is a communications tool, proving to be very effective, what should happen when a topic is brought up that is outside of the limited scope of the group? Not every Trustee is a member of the WhatsApp group.

**Something needs to be discussed by the whole group because they may affect Gamblers Anonymous as a whole. For example: A Trustee from an International location asked for advice about the actions of a Trustee in the United States that was causing problems within their area. What should be done? How do we communicate what is happening to other Trustees or the Executive Committee?**

**This Trustee within the United States has an official position within the Board of Trustees, besides being a Trustee. He was mentioned by name. This issue has International, local and Gamblers Anonymous as a whole opportunities.**

**Most of the discussions are questions on what should happen within the rooms and how to handle different situations.**

**The committee is researching other apps that can be used with the same effectiveness as the WhatsApp currently is such as telegram and others.**

**It is recommended by the committee, that all members of the Board of Trustees use the WhatsApp program, including the Executive Board. Even though we would like all members to be part of the Trustees WhatsApp group, we realize that they do not have to, but most communications are done through the app including committee communications, it is highly recommended that everyone does.**

**Upon approaching the staff to start the necessary paperwork, was informed that due to staffing cut and lack of sustained interest by the prisoners, the meeting has been suspended. All attempts to restart under the guidance of GA membership were rejected.**

**3. London, Ohio- Very active meeting run by prisoners. Arranged for me to visit in early February 2025 to observe the meeting and encourage prisoners involved. Over 120 prisoners from all 12 Step programs and may addicts not in recovery attended.**

**Turned into an impromptu interactive lead.**

Four prisoners reached out for literature. One requested meetings in St. Cloud, MN as his release was in March from a Maryland prison. A woman in a Henderson, TX facility, and one man in a Covington, LA facility. A 4th was a military prisoner from the Annex in Leavenworth, KS looking to start a meeting. Each received prisoner literature from Israel and a letter from me directly answering their questions.

The committee has worked for the past 2 years changing the guidance code and making new rules and procedures where needed to implement the usage of digital media to host online trustee meetings. Every effort was made to ensure the same ‘feeling’ of a physical meeting within the online trustee meeting. Several “test” online meeting were held to make sure that the system we are recommending will work for our needs. With every meeting changes were immediately noticed until our final meeting was held on March 1 with everyone attending and participating realizing that the format will work. There were 32 participants who were on that particular meeting. 26 were Trustees the others were committee members 1 Trustee was from Iran, 3 from the Philippines, 2 from South America. Since this is a new format for our program as a whole, we need to

remind everyone that this process is a fluid one. We will need to adapt where we find procedures will not work and be able to make ones that will. For example we found that the system will recognize people who have their hand up in order, but the host only “sees” a few participants not everyone at the same time, so we need “monitors” who can communicate with the host to recognize the participants in the proper order.

With the Rules and Procedures that the Committee has recommended, it was intentional that nothing was named as far as system, App, program etc. That will allow our program to change out any part of the program as long as a single majority vote of the B.O.T. happens. If something is not specifically listed in the Rules and Procedures for Digital Trustee Meeting but otherwise listed in the Rules and Procedures for Trustee Meetings then the later will apply. Isreal reached out asking to get permission to translate more of our GA approved literature when we found out they had translated UK books, so the committee explained to be a GA approved group they must use our literature. The website had five meetings, and they told us they have 24 groups now. So, I sent out a new group form and waiting for them to filled out for all the groups. Also, there were inquiries about gammon. Iran contacted me with their new trustee; they had two spots approved but only one trustee. Now they have two. We received questions about starting meetings and being official from Peru which I tried helping them out. Also, we had calls for help with finances and getting to virtual meetings that we had to explain that we cannot help financially but support their access to groups and recovery. They calls came from many countries such as Indonesia and South Africa. Our GA brothers and sisters from Spain Argentina and Mexico have taken the task to translate the new version of the Blue Book, the process took over a year and has now been published and is available through the ISO. Mexico has purchased the first 200 and will soon be ordering more. The committee members from Mexico are constantly updating the website and helping where needed.
